Russiaville Town Hall
February 11, 2025

Council Present – Roger Waddell, Pat Reel, Don Parvin, Greg Landrum, and Jake Gibson

Corbin King, attorney, was also present.

Bob Webb said a prayer. The Pledge of Allegiance was recited.

Treasurer's Report - Megan Reel gave written reports. Megan added that she had gotten a podium, and if all goes as planned the Livestream equipment will be installed this Saturday. The AFR (Annual Financial Report) was submitted and will be in the paper February 17th. End of year is finished, and she is working on a PERF audit. Megan is changing the community center agreement to reflect the new rate of \$300.00, and a few small verbiage things. If the council is ok with it, she will get everything to Rhiannon to be changed and effective on Monday February 17th. The council all agreed that would be fine.

Megan also said as long as she can get it in the newspaper in the timeframe it needs to be, the public hearing for the annexation will be on our next meeting date of March 11th at 5 pm.

Minutes from January 14, 2025 meeting and special meeting on January 22, 2025 were approved.

Streets/Wastewater – There was no report.

Marshal's Dept. – Josh Fulkerson was present and had written reports.

EMA Advisory – Josh Fulkerson said there was nothing new to report.

Public Safety – Jake Gibson said there is nothing new to report.

Health Department – February 19th at 6:30 pm is the next preparedness meeting at the Lions Club.

Attorney Comments – Corbin King said there was some more correspondence about the floodplain administrator. Corbin will find about this as the county takes care of all floodplain things for us.

Corbin said as far as the TIF non-voting school board member, he doesn't think we really need to have someone from the school board on TIF as the school is not in town limits. However, it is ok if there is one on there as a line of communication between us. Roger Waddell asked if he did it correctly at the last meeting, and Corbin said he thinks it is fine.

Plan Commission – Mike Kanable was present and had no new business to report.

Board of Zoning Appeals – No new business to report.

TIF Board – No new business to report.

Historical Society – Nothing new to report.

Park and Tree Board – Megan Reel said that Jill Newby could not be here tonight but she is looking for jobs for the seniors on community day. It is April 24th.

Dave Kieser – Megan Reel said she talked to Dave and he is working on a possible sidewalk grant.

Farmers Market – Lexi Hunt was present to talk about having the market again this year. Lexi said it would be on the second Sunday of the month again, from June – October from 11am – 2pm. Pat Reel made a motion to allow the Farmer's Market to be held in the same place behind the Town Hall for this year. And as always, he is happy to help with set up, barricades, etc. Don Parvin seconded, and the motion carried with Pat, Don, Greg, and Jake voting for passage.

Zoning on Main St. – Megan said she had a complaint about bushes, and has since spoke with the owner. The owner said he would get them trimmed, but it would be 2 – 3 weeks before he could get it done. Hopefully he will and we won't have to take further action.

Megan Reel said she had received a letter from Conrad Maugans about a quitclaim deed from Timothy Carter to the Town in 2012 for a small portion of a street in Honey Creek Hills. At the time it was just not recorded, and has since been done. This is informational, nothing we need to do.

Pat Reel said the AmVets Chili Cook-off this past Saturday went well and thanked everyone for coming out to support the AmVets.

There being no further business to be brought before the council, the claims, receipts, payrolls, bank recs, and time sheets were presented and approved. Pat Reel made a motion to adjourn the meeting. Don Parvin seconded, and the meeting came to an end at 5:34pm.
