Regular Council Meeting
Russiaville Town Hall
January 13, 2026

Council Present – Roger Waddell, Pat Reel, Don Parvin, Greg Landrum, and Jake Gibson
Corbin King, attorney, was also present.

Roger Waddell called the meeting to order.

Don Parvin said a prayer. The Pledge of Allegiance was recited.

Election of Officers for 2026:

Pat Reel made a motion to nominate Don Parvin as President. Jake Gibson seconded, and the motion carried with Pat, Jake, Greg, and Roger voting for passage.

Jake Gibson made a motion to nominate Pat Reel as Vice President. Roger Waddell seconded, and the motion carried with Jake, Roger, Don, and Greg voting for passage.

Minutes from December 9, 2025 meeting were approved.

Treasurer's Report – Megan Reel gave written reports. Megan said the FIT and CVET money is no longer coming into and divvied out amongst the general, MVH, and CCD. It comes into our general fund, and we can decide where to put it. She feels since we always need money in our general fund that would be the best place for it. Pat Reel made a motion to put the FIT and CVET money into the general fund going forward. Roger Waddell seconded, and the motion carried with Pat, Roger, Don, Greg, and Jake voting for passage.

Megan also reminded everyone that January 22nd is the first day for the new trash day. It will be Thursday from now on.

Streets/Wastewater – Craig Thompson was present and had a written report. Craig said a pump is needed for Honey Creek Hills. The quote is \$4,548.00. Pat Reel made a motion to approve the pump. Jake Gibson seconded, and the

motion carried with Pat, Jake, Don, Greg, and Roger voting for passage. Craig had an estimate of some tools that he needs from Lowe's in the amount of \$500.00. Pat Reel made a motion to approve the purchase. Roger Waddell seconded, and the motion carried with Pat, Roger, Don, Greg, and Jake voting for passage. Craig said there are 7 air relief valves for the force main that comes down 750 W. One of them was hit and needs to be fixed, also they all need to be serviced and cleaned. They have been there for 8 years and we have not done this and it should have been done by now. Craig had a verbal quote to get the one fixed and the rest serviced of just under \$3,000.00. They will let us know how bad they are and if they need to be serviced more often. Pat Reel made a motion to approve the work to get the one air relief valve fixed and the rest serviced. Jake Gibson seconded, and the motion carried with Pat, Jake, Don, Greg, and Roger voting for passage.

Marshal's Dept. – Josh Fulkerson was present and had written report, including a yearly report. Josh had verbiage from the insurance saying that any moonlighting would be covered on our insurance policy. Corbin King asked if they would be covered by workers comp. Josh said he is not sure on that, but it does say there would need to be an indemnified contract between the two parties. Megan Reel will find out about workers comp. Roger Waddell made a motion to table this until next month until we have all the info. Pat Reel seconded, and the motion carried with Roger, Pat, Don, Greg, and Jake voting for passage. Josh said the Tahoe's are very close to being done, they are waiting a few things.

EMA Advisory – Josh Fulkerson said there was nothing new to report.

Public Safety – Jake Gibson said there is nothing new to report.

Attorney Comments – Corbin King said he had nothing new to report.

Park and Tree Board – Jill Newby was present and said Dave Kieser is finishing up with everything for the DNR. Hopefully we will be approved to order equipment soon. They are hoping to have this completed by June 1st; therefore, they would have to start excavation the first part of April. This is if the weather cooperates, and all goes well.

They will be working with Lori from the Library for Arbor Day this year in April.

Plan Commission – Mike Kanable was not present but left a written report.

Board of Zoning Appeals – No one was present to report.

TIF Board – No one was present to report.

Health Department – Megan Reel said that Rick Homkes asked her to report the total numbers for Russiaville from 2025. Megan said there were 17 sessions in 2025, total attendees was 259, and there were 95 people that had first aid training.

Historical Society – No one was present to report.

Community Service Award for 2025 – Peggy Hollingsworth was honored to be added to the plaque as our towns Community Service Award recipient. Peggy said a few words and thanked everyone. The council thanked her for all she does for our town.

New Employee Process – Don Parvin said we are still working on this and will table it for now.

Lori Seaman – The Gene Parks run will be April 11th. The library is going to host a scavenger hunt that will introduce people to our small businesses and the library, this will replace “dance across Russiaville.” This will lead up to April 11th, there will still be the pancake breakfast at the Lions Club, and they will have a kite festival this year at the community center park. A Hoosier Kite Fliers founding member will be there and fly the big kites, and kids can put together kites and be able to fly them as well, and be some fun activities.

They are thinking about doing the bike rodeo in July this year, and September 26th will be the food truck and bonfire event. Outdoor movies at the library will be May 16th - October.

Lori said since we are helping her by allowing her to utilize the community center for her bigger programs like yoga and line dancing, she would like to suggest a pamphlet on how to rent the building. People ask when they are there for these

events and it would be beneficial to have some information there to be able to give them.

Pat Reel would like to put up hometown hero banners on the black poles opposite the current ones and some on the bigger wooden poles down by McClure for overflow. This would give us a total of 80 banners. Pat said he would like to leave up a seasonal "welcome" banner on each end of town like it currently. Pat said we have 32 on the waiting list at this time. There was a question about the brackets that are up there, and Pat said if brackets were broken, he would replace as needed. As before the AmVets will take care of the whole process. Jake Gibson made a motion to allow the AmVets to put sell and put up more banners on black poles and wooden poles. Greg Landrum seconded. Don Parvin abstained. The motion carried with Jake, Greg, Pat, and Roger voting for passage.

Comments from guests – Tracy Powell, Tipton County Commissioner, was present to introduce himself. He is running for Senate District 21.

There being no further business to be brought before the council, the claims, receipts, payrolls, bank recs, and time sheets were presented and approved. Pat Reel made a motion to adjourn the meeting. Greg Landrum seconded, and the meeting came to an end at 5:45pm.
